# Sales Contract

**1. The following is in agreement in the terms of the NES light Company**

**2. Late payment.** If customer fails to pay in 60 days from the invoice date, there will be a charge of 3% of the original amount per month that it is late. In case the customer cannot pay in 90 days from the invoice date, the late fee will be 5% of the original price.

**3. Use of Item.** Customer acknowledges that use of the Equipment creates some risk of personal injury to customer and third parties, as well as a risk of damages to property, and customer expressly assumes that risk. Customer therefore agrees to use the Equipment safely and only in the manner for which it is intended to be used. Owner is not responsible for an personal injury or property damage resulting from customer’s misuse, unsafe use of reckless use of the Equipment. Customer will indemnify and defend owner from and against any injury or damage claims arising out of customer’s misuse, unsafe use, or reckless.

**4. Entire Agreement.** This is the entire agreement between the parties. It replaces and supersedes and all oral agreements between the parties, as well as any prior writings

**5. Successors and assignees.** This agreement binds and benefits there heirs, successors, and assignees of the parties.

**6. Notices.** All notices must be in writing. Notice may be delivered to a party at the address that follows a party’s signature to a new address that a party designates in writing. A notice may be delivered:

(1) in person, (2) by mail, (3) by Email, or (4) FAX

**7. Severability.** If any court determines that any provision of this agreement is invalid or unenforceable any invalidity or unenforceability will affect only that provision and will not make any other provision of this agreement invalid or unenforceable and shall be modified, amended, or limited only to the extent necessary to render it valid and enforceable.

**8. TAX ID.** By signing this contract you are confirming that the information on the ST-3 New Jersey Tax Exemption is correct and up to date. In that, in any circumstances of the information that is not correct, the signer will be responsible of any circumstance that there will be in the State of New Jersey.
